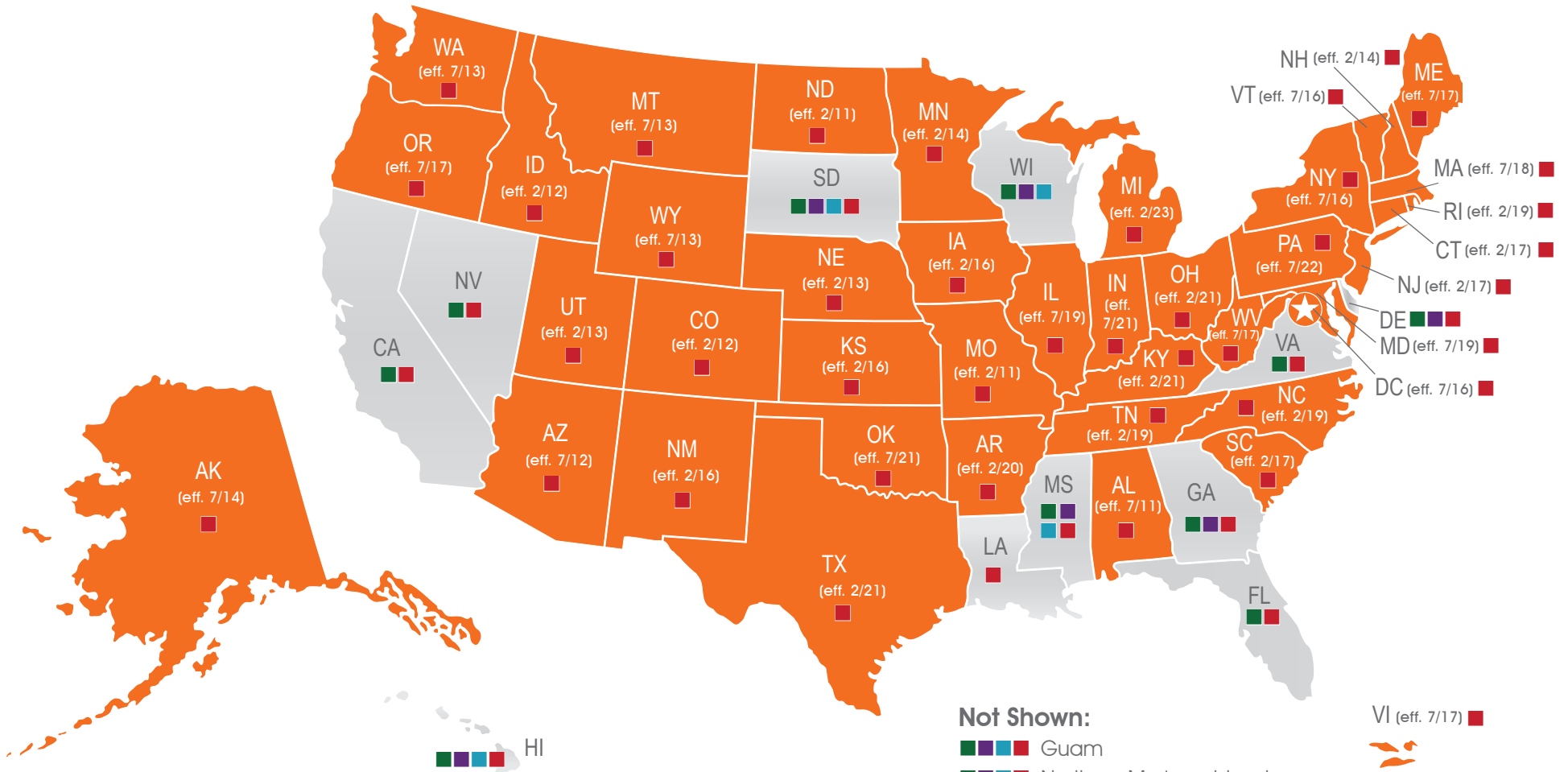


Adoption of the Uniform Bar Examination with NCBE Tests Administered by Non-UBE Jurisdictions
